A **Consigliere** ([Italian consigliere](#) "counselor", pronounced [[kɒnsɪˈʌɪːrɪ](#)], roughly *kohn-see-YEHR-eh*; plural *consiglieri*) is a position within the leadership structure of the [Sicilian](#), [Calabrian](#) and [American Mafia](#). The word was popularized by the novel *The Godfather* (1969) and [its film adaptation](#). In the novel, a consigliere is an advisor or counselor to the [boss](#), with the additional responsibility of representing the boss in important meetings both within the boss's crime family and with other crime families. The consigliere is a close, trusted friend and confidant, the mob's version of an elder statesman; he is an adviser to the boss in a Mafia crime family, and sometimes is his 'right-hand man'. In some depictions, he is devoid of ambition and dispenses disinterested advice. By the very nature of the job, a consigliere is one of the few in the family who can argue with the boss, and is often tasked with challenging the boss when needed, to ensure subsequent plans are foolproof.[\[1\]](#)
